# **Privacy Policy/GDPR**

Amanda at Neurodiverse Adventures ("I") are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data that I collect from you, or that you provide to myself, will be processed by me. Please read the following carefully to understand my views and practices regarding your personal data and how we will treat it. Information you give to me

It may also arise from when you change/update your personal details, contact preferences etc. and when you report a problem with my various media sites. The information you give me may include your name, address, e-mail address and phone number.

Information I collect about you.

About each of your visits to my media sites, I may automatically collect the following information:

Technical information, including the Internet protocol (IP) address used to connect your computer to the Internet.

Your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system, and platform.

Information about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time)

Products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page and any phone number used to call myself.

#### Cookies

All visitors to my website are notified that I collect Cookies. I will use this information:

To administer my site and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes.

To improve our site to ensure that content is presented in the most effective manner for you and for your computer.

To allow you to participate in interactive features of my service when you choose to do so.

As part of my efforts to keep my site safe and secure.

To measure or understand the effectiveness of advertising I serve to you and others, and to deliver relevant advertising to you.

To make suggestions and recommendations to you and other users of my site about goods or services that may interest you or them.

Information I receive from other sources. I may combine this information with information you give to myself and information I collect about you. I may use this information and the combined information for the purposes set out above (depending on the types of information we receive).

## Disclosure of your information

Provided always that you have provided the necessary consent(s),

If I am under a duty to disclose or share your personal data in order to comply with any legal obligation, or to protect the rights, property, or safety of National Federation of Self Employed and Small Businesses Limited, my customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

### Where I will store your personal data

The data that we collect from you will be stored at a within the European Economic Area ("EEA") and will not be transferred outside the EEA unless I have your explicit consent to such transfer and storage. In any event, your data will only ever be transferred to organisations where an approved code of practice in relation to data protection is adopted. I will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

Although I will do my best to protect your personal data, I cannot guarantee the security of your data transmitted to my site; any transmission is at your own risk. Once I have received your information, I will use strict procedures and security features to try to prevent unauthorised access.

#### **Retention Policy**

All data is reviewed every twelve months. Any unnecessary date is then reviewed and deleted.

I regularly review information and erase or anonymise personal data when I no longer need it.
